**Directions:** From the East, take the LIE going West, to Exit 55 toward Suffolk County 67/Central Islip/Motor Pkwy, and merge onto LIE North Service Rd. Turn right at County Rd 67/Long Island Motor Pkwy/Motor Pkwy, turn right at Adams Ave, then take the 3rd right onto Suffolk Ct and go all the way to the far back (the shop will be on the right). From the West, take the LIE going East, to exit 53 toward Bay Shore/Kings Park/Sagtikos State Pkwy, and merge onto LIE Service Rd. Continue onto Crooked Hill Rd, take the ramp to Wicks Rd, then turn left at Wicks Rd. Take the 1st right onto County Rd 67/Motor Pkwy, take the 1st left onto Adams Ave, take the 3rd right onto Suffolk Ct and go all the way to the far back (the shop will be on the right).
